Re: Approval of Agenda

Upon a motion by Mr. Zubrod, seconded by Mr. Jones, and unanimously carried, the Board approved the agenda as presented.

FY19 Budget Request

Dr. Kristy Somerville-Midgette, Division Superintendent, gave an overview of the public schools FY19 budget. Dr. Midgette stated that upon her taking office and review of the budget, it was noted that there is a deficit in the adopted budget due to state revenues being overstated and staff error.

In an effort to address the budget deficit, Dr. Midgette made several personnel cuts. However, the cuts do not address the budget deficit in totality. As a result, Dr. Midgette requested a total of \$241,558 for FY 2019. Of that request, \$191,558 will cover the salary increases for teachers and classified personnel that were approved by the school board on June 25, 2018. The additional \$50,000 will cover a one-time cost of professional development for reading instruction at the elementary and middle school levels.

If the aforementioned request is approved, any unexpended funds from the public school's FY 2018 budget will be absorbed by the County. Further, the County must allocate an additional \$191,558 to future public school budget to cover the salary increases for teachers and classified personnel.

Upon a motion by Mr. Zubrod, seconded by Mr. Jones, and unanimously carried, the Board referred the school board's request to the Finance Committee for consideration and recommendation to the Board of Supervisors.
