Rezoning Case #18-036 – Submitted by David and Essie Jones, to rezone the subject property from Agricultural (A-1) to Business (B-1)

Mr. George E. Morrison, III, Director of Planning, stated that the applicants are requesting to rezone the subject property from Agricultural (A-1) to Business (B-1) to use the existing building located on the subject property as a multi-purpose building. The subject property is located on the west side of Liberty Road (State Road 634), approximately 900' feet north of the intersection of Old Stage Road (State Route 712) and Liberty Road, in the Sturgeon Magisterial and Election Districts.

The Planning Commission conducted a public hearing regarding this request at their February 12, 2019, meeting. No one spoke in opposition to the request. At the conclusion of the public hearing, the Planning Commission voted unanimously to recommend approval of the request.

FY19 Financial Report

Mrs. Kristen Choate, Robinson, Farmer, Cox Associates, presented the findings in

the Brunswick County Financial Report Year Ended June 30, 2018. She reviewed the "Communication with Those Charged with Governance" letter, stating that there were no disagreements or difficulties with management in performing the audit. An unmodified opinion was issued on the financial statements, which reflects that the County's financial statements were fairly stated in accordance with generally accepted accounting principles.

Brunswick County Sheriff's Office Accreditation

Sheriff Joe McLaughlin, New Kent County, presented Sheriff Brian K. Roberts and the Brunswick County Sheriff's Office with a Certificate of Accreditation. He congratulated the Sheriff's Office for meeting the requirements as set forth by the Virginia Law Enforcement Professional Standards Commission to become an Accredited Agency.

The Board of Supervisors thanked the Sheriff and his staff for their diligent efforts to maintain accreditation since January 2007.

Economic Development Coordinating Council

Mr. Robert F. Pecht, III, Chair of the Economic Development Coordinating Council (EDCC), provided an overview of the EDCC's projects stating:

- Supporting efforts to continue improving the Brunswick County school system is not only important to our Brunswick County children presently here but is also critically important to attracting new economic development to Brunswick County. We thank the Board of Supervisors for supporting the feasibility study for the Brunswick County Public School system.
- The presence of the Southside Virginia Community College campus in Brunswick County is a huge economic development asset. The new Student Center currently under construction in Alberta represents an additional major investment in Brunswick County by SVCC. We encourage efforts to increase awareness of the many opportunities available to Brunswick County citizens to attain valuable workforce credentials and to further their education.
- Lake Gaston constitutes a significant percentage of real estate tax revenues for Brunswick County and is a tremendous asset for the county. The availability of lake properties which allow short-term rentals is a factor that affects property values.
- Seek opportunities to strengthen infrastructure wherever possible throughout Brunswick County, not only with water and sewer but also with broadband and cell phone coverage. Coordinate efforts with other entities whenever possible.
- Saint Paul's College was throughout its history a very important part of Brunswick County and the closing of the College has left a huge void. The future

- use of the property is of critical importance to the future of Brunswick County. We support that the County is forming a "task force" to address this important issue.
- We thank the Board for hiring a full-time person, Dixie Walker, dedicated to tourism efforts to keep the momentum going on tourism that has previously come only from dedicated volunteer efforts. Volunteer efforts for tourism are still greatly needed, and we encourage citizens to participate. We also encourage coordination of tourism efforts wherever possible.
- We support the efforts of Mike Dotti and the group of Brunswick County citizens studying the feasibility of forming a YMCA which would be under the umbrella of the Emporia YMCA. Improving quality of life is an important component of economic development.

Brunswick Byways Visitor Center Certification

Dr. Charlette T. Woolridge, County Administrator, stated that the Brunswick Byways Visitor Center has been identified as a Certified Tourist Information Center by the Virginia Tourism Corporation. Dr. Woolridge recognized Dixie Walker, Tourism Coordinator, and Carthan Currin, Director of Economic Development, for their work on obtaining the certification.

Agriculture and Timber Conference Update

Mr. Carthan Currin, Director of Economic Development, gave and update of the Agriculture and Timber Conference that was held on February 19, 2019, at the Brunswick County Conference Center. Mr. Currin stated that the conference was a huge success with 135 attendees. He thanked the Board of Supervisors, Secretary Bettina Ring, the committee and the corporate sponsors for their support.
