Courthouse Security Fee Assessment

Dr. Woolridge stated the Code of Virginia allows counties and cities to assess a courthouse security fee in each criminal and traffic case in its district and circuit courts. These fees are to be used solely for the funding of courthouse security personnel, equipment, and other personal property used in connection with courthouse security.

The 2020 General Assembly approved a fee increase from \$10 to \$20 per court case. In order to allow the courts to assess the maximum fee allowed per the Code of Virginia, the Board of Supervisors must first hold a public hearing to allow citizen input on the change to Brunswick County's Code of Ordinances.

- Friday, June 26, 2020, 10:00 a.m. to 2:00 p.m. (partnership between County of Brunswick and Virginia Department of Health)

Tests are available on first come first served basis, no insurance needed, no

appointment needed and this is a free service.

Resolution – COVID-19 Small Business Recovery Assistance

Ms. Leslie R. Weddington, Assistance County Administrator, stated that

Brunswick County will be applying for up to \$550,000 from the Virginia Department of

Housing and Community Development for the Small Business Recovery Assistance

Community Development Block Grant. The Small Business Recovery Assistance grant is strictly in response to business owners adversely affected by the COVID-19 Pandemic. Funds will be used to relieve and reduce unemployment, assist with job retention and working capital needs necessary to sustain businesses through the pandemic. Eligible businesses will be able to apply for up to \$10,000 in assistance. Brunswick County is required to conduct two public hearings. The first public hearing will be held on Tuesday, June 30, 2020, at 6:30 p.m., and the second public hearing will be on Tuesday, July 7, 2020, at 6:00 p.m. Both meetings will be held electronically. Southside Planning District Commission will facilitate the public hearings and manage the grant process. A resolution stating that Brunswick County will be applying for these grant funds and authorizing the County Administrator to sign all documents relative to the grant is required to be adopted.

Upon a motion by Mr. Jones, seconded by Dr. Seward, and unanimously carried, the Board adopted the following resolution:

WHEREAS, the County of Brunswick wishes to apply for Community Development Block Grant funds up to \$550,000 from the Virginia Department of Housing and Community Development for the Brunswick County Small Business Recovery Assistance Project, and

WHEREAS, through the Small Business Recovery Assistance Fund, the County of Brunswick will help businesses meet their long-term business goals by adjusting to COVID-19 demands, by establishing safe and clean re-opening procedures, in accordance with the Governor's guidance, necessary for the safety of customers and employees. Also, allowing businesses to regain and sustain operations, ideally helping them retain existing staff, fill vacant positions, create new jobs, and become more efficient and resilient.

WHEREAS, citizen participation requirements will be met by holding two (2) public hearings, all advertised appropriately with at least one other form of public notice; and

NOW, THEREFORE, BE IT RESOLVED, that the County of Brunswick authorizes Charlette T. Woolridge, Ph.D., County Administrator, to sign and submit all appropriate documentation necessary to constitute an application to the Virginia Department of Housing and Community Development for the request of Community Development Block Grant funds and to accept and appropriate all funds received.
