#### **BRUNSWICK COUNTY GOVERNMENT**

- Dr. Charlette T. Woolridge provided an update on the Commonwealth of Virginia's confirmed COVID-19 cases (3,333) and deaths (63) as of this afternoon.
- The number of confirmed cases in the region are as follows:
  - Brunswick County: 1 confirmed case
  - Halifax County: 2 confirmed cases
  - Mecklenburg County: 12 confirmed cases
  - Emporia: 2 confirmed cases
  - Greensville: 4 confirmed cases
- On April 6, 2020, the Governor urged people to wear masks based on guidance from the Center for Disease Control (CDC).
- IT'S IMPORTANT THAT WE CONTINUE TO TAKE COVID-19 SERIOUSLY!
- Dr. Woolridge emphasized the need to continue to follow federal and state protocol to include, but not limited to, practicing social distancing, washing hands, avoiding gatherings of ten or more people, wear face mask, to name a few.
- Several agencies have requested personal protective equipment (PPE) to include Social Service and Brunswick County Public Schools. We have not received our shipment of PPE and unfortunately, we do not know when we'll receive them. If there are other agencies that are in need of PPE, please send the County Administrator an email of needs.
