# **Re: Virginia Department of Transportation**

Mr. Tommy Johnson, Assistant Residency Administrator, presented the monthly report as follows:

#### Maintenance Forces

- Primary mowing is completed. Secondary mowing ongoing.
- Patching potholes as needed.
- Cut brush/limbs on various secondary routes.
- Machined shoulders on various routes.
- Machining National Highway System (NHS) roadways and hauling stone as needed.
- Performed routine maintenance and litter patrol on various routes.

Mr. Johnson reported on the following projects:

- I-85 North Bound Lane and South Bound Lane Preventative Bridge
   Maintenance Project over CSX Railroad Major progress has been made over the last several weeks. Project will be completed by late summer 2017.
- Route 58 East Bound Lane Bridge over Great Creek Project should be completed and the lane closure removed by Friday, July 28, 2017.
- Revenue Sharing Project Route 642 Zero Road Work has begun. Weather permitted, project should be completed before winter.
- Revenue Sharing Project Route 732 Lloyd's Run Place The FY18 application
  was not approved for funding. The number of applications received exceeded
  the available funding and only applications for existing revenue sharing
  construction projects were funded this year. The next request for applications
  will be for a two-year cycle (FY19 and FY20). The recommendation is to apply
  again for funding.

**Heat Advisory**

103° to 108°. Mr. Hyde stated that this would be the longest streak of consecutive days of 100° of higher since August 29 through September 2, 1950.

Mr. Hyde recommends limiting outdoor activity during the heat period and advises citizens to stock up on water, ice and sports drinks that contain electrolytes.

Schedule Public Hearing: Rezoning Case #17-012 – Submitted by James Hodges, to rezone subject properties from Agricultural (A-1) to Residential, Limited, (R-1) Zoning District

Mr. George E. Morrison, III, Director of Planning, stated that the applicant is requesting approval to rezone the subject properties from Agricultural (A-1) to Residential, Limited, (R-1), to develop a thirty-eight (38) lot subdivision. The subject property is located on the north side of Hendricks Mill Road (State Route 903), approximately 30 feet from the intersection of Poplar Creek Road (a private drive) and Hendricks Mill Road, in the Meherrin Magisterial District. The Planning Commission conducted a public hearing on this request at their July 11, 2017, meeting. No one spoke in opposition to the request. At the conclusion of the public hearing the Planning Commission voted unanimously to

recommend approval of Rezoning Case #17-012 and request the Board of Supervisors to schedule a public hearing for the August 16, 2017, regular meeting.

## **Broadband**

Dr. Woolridge stated that Virginia's Growth Alliance met with representatives from the Center for Innovative Technology (CIT) Broadband to discuss broadband needs in Southside Virginia.

CIT is the only resource in the Commonwealth that offers a "holistic" supply and demand approach to solving the broadband equation. The current mission of CIT's Broadband Program is to "accelerate the socio-economic growth of Virginia's rural and underserved areas through the application and use of broadband telecommunications."

The CIT Broadband team has the knowledge, experience, methodology and tools to perform a comprehensive assessment of existing services, assets and infrastructure to guide the development of a strategic broadband plan for communities. CIT's team

leverages the Commonwealth's proven Broadband Toolkit methodology in concert with

Virginia's broadband mapping data and broadband deployment planning tools to:

Identify gaps in broadband service

Identify key vertical assets that could address the un-/under-served areas

Provide funding options for new infrastructure

Define strategies for partnering with incumbent providers and

Document methods for addressing broadband awareness and adoption to

improve utilization for all citizens.

There is no cost to the County for CIT services.

the Board authorized the County Administrator to request CIT Broadband to conduct a

comprehensive broadband needs assessment for Brunswick County.
